CalWEA Membership Levels

Companies of each type must subscribe at or above the tier level indicated. Some exceptions may be made for new members, with approval of CalWEA's Executive Committee.

Level	Type of Company	Dues	Vote Weight*	Notes / Benefits
Tier 1	Project owners and developers	\$35,000**	3	Voting member of CalWEA. Eligible to serve on Board and all substantive committees. Receive all communications.
Tier 2	Major equipment suppliers	\$20,000	2	Voting member of CalWEA. Eligible to serve on Board and all substantive committees. Receive all communications.
Tier 3	Small vendors, subcontractors and consultants	\$10,000	1	Voting member of CalWEA. Eligible to serve on Board and all substantive committees. Receive all communications.
Sponsorship	Companies that wish to support our activities but whose internal policies do not allow membership or are otherwise unable to join at a higher level.	\$5,000	0	Non-voting member of CalWEA. Receive periodic updates, action alerts, and information upon request.

* Applies to CalWEA's position on substantive issues (if put to a vote), election of directors, and other matters as specified in CalWEA's Bylaws. (To date, all decisions have been made by consensus and we hope to continue that practice. However, if decisions have to be made, those companies paying more will enjoy greater voting strength.)

** Participants in the BLM Master Agreement will have a supplemental dues requirement (amount TBD, but estimated at \$5,000) to support implementation activities.
